

Immunization Requirements for Murray State College Students In Compliance with Oklahoma Statutes

Certification of Compliance Hepatitis B, Measles, Mumps and Rubella (MMR)

Oklahoma Statues, Title 70 3244, requires that *all students* including *international students* who enroll as full-time or part-time student in an Oklahoma public or private postsecondary institution provide documentation of vaccinations against hepatitis B, measles, mumps and rubella (MMR).

The statue requires that Institutions notify students of the vaccination requirements and provide students with education information concerning hepatitis B, measles, mumps and rubella (MMR), including the risks and benefits of the vaccination.

The statute permits that when the vaccine is medically contraindicated and licensed physician has signed a written statement to that effect, such student shall be exempt from the vaccination. Further, the statue permits a student or if the student is a minor, the student's parent or other legal representative, to sign a written waiver stating that the administration of the vaccine conflicts with students moral or religious tenants.

Vaccination	Who must comply	Compliance Requirements	Compliance Data
*Meningitis	All new students living in campus housing	Proof of Vaccination	At Move in
Measles, Mumps, Rubella, TWO DOSES	All new students born after January 1, 1957	Proof of vaccination with 2 doses of vaccine; or lab test demonstrating immunity; or, signed Certificate of Exemption	At enrollment
Hepatitis B	All new students	Proof of completion of a Hep B series or signed Certificate of Exemption	At enrollment
**Tuberculosis Skin Test	All new International Students	Proof of negative test results in the United States	If test result positive must have chest x-ray verification that student does not have TB.

*Specific information regarding immunization for meningitis: Oklahoma law require that first time enrollees who reside in on-campus student housing be vaccinated against meningococcal disease UNLESS: 1) the individual signs a waiver that he/she has chosen not to be immunized or, 2) in the case of a minor, the individual's parent or legal guardian signs the waiver.

**The Oklahoma Health Department requires that TB testing be conducted in the United States (NO Exceptions).

International Students who provide immunization records from their home country must be translated into English.

All required immunizations are available at Local area Health Departments.

Housing Students must provide a copy of immunization records to the Admission Office and the Student Housing Office.

Campus Students attending at the University of Southern Oklahoma and the main campus need to provide a copy of immunization records to the Admission Office in Tishomingo.
