Purpose: The Murray State College Institutional Animal Use and Care Committee (IACUC) is responsible for the oversight and evaluation of all aspects of animal care and use for teaching purposes. The IACUC reviews all animal use protocols, ensures compliance with federal regulations, and inspects animal facilities and laboratories.

Responsibilities:

- The committee must meet a minimum of every six months (August and February).
- Records of committee meetings and deliberations should be maintained.
- Review animal use protocols and attachments (August meeting) annually.
- Review policies and plans (February meeting) annually.
- Facility inspections are conducted at each meeting.
- Make recommendations regarding any aspect of the animal program, facility, or personnel training.
- Reports of the IACUC meetings and facility inspections are submitted to the Institutional Officer.

- Review and investigate legitimate concerns involving the care and use of animals.
