

 - c. College transcripts, if applicable (must send **OFFICIAL** if accepted for enrollment purposes) (please send additional copies (can be unofficial) to the gunsmithing department)
 - d. Immunization records
3. **Submit to the Gunsmithing Program:**
 - a. Application for Admission to Gunsmithing Program (this form)
 - b. Cover letter/Biography (See "Cover Letter, Bio & Research Assignment" Sheet for instructions)
 - c. 3 letters of recommendation (See "Cover Letter, Bio & Research Assignment" Sheet for instructions)
